## RESOLUTION OF THE BOARD OF DIRECTORS OF STALLION MEADOWS ESTATES PROPERTY OWNERS' ASSOCIATION, INC. REGARDING FINE AND ENFORCEMENT POLICY

Pursuant to Section 209.0061, Texas Property Code, Stallion Meadows Estates Property Owners' Association, Inc., hereinafter referred to as "Association", acting by and through its Board of Directors, has adopted the following fine and enforcement policy to set forth its policy for levying fines, to-wit:

### 1. Schedule of fines.

- A. <u>CATEGORY 1</u>: \$25.00 per day. This fine will be charged daily until the violating condition is corrected.
- B. <u>CATEGORY 2</u>: \$35.00 per day. This fine will be charged daily until the violating condition is corrected.
- C. <u>CATEGORY 3</u>: \$50.00 per day. This fine will be charged daily until the violating condition is corrected.

### 2. Board's authority to grant variance on fines.

The Board is granted the authority to adopt and access a different fine amount on a case by case basis after considering all the facts of the violation. Any Category of fine can be increased for repeat offenses.

### 3. General categories of restrictive covenants for which the Association may assess fines:

- A. Building violations, for instance:
  - a. Failure to apply and receive approval from the Architectural Control Committee. (Category 3)
  - b. Failure to meet minimum square footage. (Category 3)
  - c. Failure to adhere to timeline for construction. (Category 2)
  - d. Improper construction materials. (Category 3)
  - e. Improper roofing materials. (Category 3)
  - f. Improper temporary structure. (Category 2)
  - g. Failure to have exterior color scheme approved by the ACC. (Category 3)
  - h. Improper Guest Quarter. (Category 2)
  - i. Improper Barn, Workshop and/or Storage Building. (Category 2)

- j. Failure to have a garage or carport or one improperly constructed. (Category 3)
- k. Improper fencing and light post. (Category 2)
- 1. Improper culverts. (Category 2)
- m. Improvements improperly placed within a setback area. (Category 2)
- n. Improper lighting. (Category 1)
- o. Improvements placed within a drainage easement. (Category 3)
- p. Improper water retainage structures. (Category 2)
- q. Failure to screen above ground propane tanks, pumps vent pipes and other equipment. (Category 2)
- r. Failure to screen trash containers or leave them out other than on established garbage collection days. (Category 1)

### B. Storage violations, for instance:

- a. Improper use of RV's. (Category 1)
- b. Improper storage of trailers, RV's and boats, tractors golf carts and other recreational vehicles, lawn or garden equipment or any other equipment listed in the Declaration. (Category 1)

### C. Prohibited Items on the Tract, for instance:

- a. Mobile homes, manufactured homes, modular cabins, container or move-in homes. (Category 3)
- b. Junk and debris. (Category 1)
- c. Improper garbage and trash disposal. (Category 1)
- d. Animals that do not comply with the Animal Husbandry requirement. (Category 1)
- e. Improper signs. (Category 1)
- f. Commercial activity on the Tract. (Category 2)
- g. Separately renting out a guest quarter. (Category 3)
- h. Nuisance activity. (Category 1)

### D. Miscellaneous:

- a. Failure to use the Tract for only single family residential purposes. (Category2)
- b. Failure to maintain a Tract or an Improvement on a Tract. (Category 1)
- c. Altering or removing the perimeter fencing. (Category 2)
- d. Violating any rule or regulation of the Association. (Category 1)
- e. Not having sufficient portable restrooms facilities on a construction site. (Category 1)

# 4. Information regarding hearings described by Section 209.007 of the Texas Property Code.

- A. Except as provided by subsections (C) and (D) below, and only if the Owner is entitled to an opportunity to cure the violation, the Owner has the right to submit a written request for a hearing to discuss and verify facts and resolve the matter in issue before the Board.
- B. The Association shall hold a hearing not later than the 30th day after the date the Board receives the Owner's request for a hearing and shall notify the Owner of the date, time, and place of the hearing not later than the 10th day before the date of the hearing. The Board or the Owner may request a postponement, and, if requested, a postponement shall be granted for a period of not more than 10 days. Additional postponements may be granted by agreement of the parties. The Owner or the Association may make an audio recording of the meeting.
- C. The notice and hearing provisions of Section 209.006 and Section 209.007 of the Texas Property Code do not apply if the Association files a suit seeking a temporary restraining order or temporary injunctive relief or files a suit that includes foreclosure as a cause of action. If a suit is filed relating to a matter to which those sections apply, a party to the suit may file a motion to compel mediation.
- D. The notice and hearing provisions of Section 209.006 and Section 209.007 of the Texas Property Code do not apply to a temporary suspension of an Owner's right to use Common Areas if the temporary suspension is the result of a violation that occurred in a Common Area and involved a significant and immediate risk of harm to others in the Subdivision. The temporary suspension is effective until the Board makes a final determination on the suspension action after following the procedures prescribed by this section.
- E. An Owner or the Association may use alternative dispute resolution services.
- F. Not later than 10 days before the Association holds a hearing under this section, the Association shall provide to an Owner a packet containing all documents, photographs, and communications relating to the matter the Association intends to introduce at the hearing.
- G. If an Association does not provide a packet within the period described by subsection (F), an Owner is entitled to an automatic 15-day postponement of the hearing.
- H. During a hearing, a member of the Board or the Association's designated representative shall first present the Association's case against the Owner. An Owner or the Owner's designated representative is entitled to present the Owner's information and issues relevant to the appeal or dispute.

### 5. Notice to Members:

The Association shall:

- A. Provide a copy of this Policy to an Owner of a lot in the Subdivision by:
  - a. posting the policy on an Internet website maintained by the Association or an agent acting on behalf of the Association and accessible to Members of the Association; or
  - b. annually sending a copy of the policy, separately or included in routine communication from the Association to Members, by:
    - i. hand delivery to the Owner;
    - ii. first class mail to the Owner's last known mailing address; or
    - iii. e-mail to an e-mail address provided to the Association by the Owner; and
- B. Make the policy available on any publicly accessible Internet website maintained by the Association or an agent acting on behalf of the Association.

### 6. Owner's Liability.

An Owner is liable for any fines levied by the Association for violations by the Owner, any lessees, or the Owner or lessees' family, guests, employees, agents or contractors. Regardless of who performs the violation, the Association will direct its communications to the Owner.

#### 7. Definitions.

Any words not defined in this Policy shall have the same meaning assigned in the Declaration of Covenants, Conditions, Restrictions, Easements, Charges and Liens for Stallion Meadows Estates Subdivision filed of record under Instrument No. 20230001582 of the Official Public Records of the Jack County Clerk, Jack County Texas.


